POLICY: Consent for Criminal Record Search

The Township of Limerick fully supports the principle and practice of employment equity for all persons regardless of race, ancestry, place of origin, colour, ethnic origin, citizenship, creed, sex, sexual orientation, disability, age, family or marital status, receipt of public assistance, and record of offences for which a pardon has been granted, according to the provisions of the Ontario Human Rights Code.

Employment Equity means that anyone who is qualified is entitled to take advantage of employment opportunities. This commitment to Employment Equity applies to all employment practices including recruitment, selection, compensation, training, advancement and other terms and conditions of employment respecting current and prospective employees.

PURPOSE:

The Township of Limerick is committed to undertaking initiatives to guarantee Employment Equity and to create a safe work environment that protects to the maximum recognition, utilization and development of its residents, staff and volunteers.

The goal of the Township of Limerick is to provide equal employment opportunity for all people and to work towards a balanced representation in the workforce of women, persons with disabilities, aboriginal peoples, and visible minorities.

PROCEDURE:

Prior to commencing employment, all new employees who will be responsible for handling money, providing services to children or seniors, or work with confidential information must consent to a Criminal Record Search.
