- Waterfront Lot including but not limited to Zones Limited Service Residential/Waterfront Residential
Trailer length up to and including 26' \$ 600.
Trailer length over 26' \$ 1000.
- Non-waterfront Lot
Trailer length up to and including 26' \$300.
Trailer length over 26' \$400.

Tent License Fees:

- Waterfront Lot including but not limited to Zones Limited Service Residential/Waterfront Residential
Per tent \$100.
- Non-waterfront Lot
Per tent \$50.

11	More than two (2) tents on a vacant Lot.	Section 3(vi)	\$75

13	Failure to comply with sightline provisions for placement of Tent on a Lot.	Section 3(viii)	\$50
14	Failure to display trailer license in plain view.	Section 5(iii)	\$50
